

SCHOLARSHIPS 17-18

APPLICATION DUE APRIL 25TH

Derek J. Lohmeyer Memorial Scholarship - \$500

- Must have a 'B' or better in NMSC Program
- Scholarship can be used for College/Technical classes, training courses, books, and/or tools for the trade

Norma L. Loree Memorial Scholarship - \$500

- Must have 540 hours (1 year) in NMSC Program
- Scholarship can be used for tuition or expenses to further education at a public college or vocational school

Orm & Beth Vertrees Memorial Scholarship - \$500

- Tuition for College or Technical training for NMSC student who plans to attend a technical training program at a State of Washington university or community college
- Scholarship is valid for two years after award date

Try-A-Trade Construction Trades Scholarship - \$1500

- Scholarship to be used to purchase necessary tools in the Construction Trades apprenticeship program

Sodexo Culinary Arts Scholarship - \$500

- Must be a NMSC Culinary Arts student
- Scholarship for tuition

Delbert & Lettie Roberts Memorial Scholarship - \$700

- Must have 540 hours (1 year) and have a 'B' or better in NMSC Program
- Scholarship can be used for tuition or expenses to further their education at a public college or vocational school
- Scholarship valid for two years after award date

SPSCC Academic Excellence Scholarship - 2 year Tuition Waiver

- Two-year tuition only scholarship for three quarters of full time attendance in each academic year
- Required to maintain a 3.0 cumulative GPA
- Demonstrate high probability of success at SPSCC
- Once student accesses scholarship, two-year time frame begins

New Market Foundation Scholarship - \$500

- Scholarship can be used for College/Technical classes, training courses, books, and/or tools for the trade

Quarryman Car Club Scholarship - \$700

- Scholarship can be used for tuition or expenses to further education at a public college or vocational school

TRANSALTA Scholarship- \$1500

- Scholarship can be used for Tuition or expenses
- Applicants must be from Lewis County or South Thurston County Schools

PSE Retirees Scholarship - \$1000

- Scholarship can be used for Tuition or expenses
- Preference to students who plan to attend Lineman School, however, all are welcome to apply

Phil Medgard Memorial Scholarship - \$500
